DECLARATION OF PARENT OR GUARDIAN

NOTES FOR INFORMATION OF PARENT OR GUARDIAN

1. The purpose of this form is to assist the Airline and parents/guardians to make adequate arrangements to ensure that unaccompanied children are properly looked after. The Airline will take care of unaccompanied children from the time of acceptance for a flight at the airport of departure until the time of arrival at airport destination, except where there is a scheduled night stop.
2. In the case of unaccompanied children under 12 years of age, the Airline requires that they be escorted to the airport of departure and it is particularly important that such escort does not leave the air[port until after departure of the flight, so that in the event of a flight delay or cancellation the escort may be available to take charge of the child or to authorise alternative arrangements.
3. The Airline also requires such children to be met at the airport of arrival unless a written request is made by the parent or guardian that the unaccompanied child be met at the town terminal. However, in such cases, the Airline cannot accept responsibility for the child after arrival of the flight at the airport. This particularly applies at a busy international airport such as Harare Airport.
4. In the case of unaccompanied children of 12 years of age or over, The Airline recommends that they be accompanied to the airport of departure and for younger children but the decision as to whether children in this age group are to be escorted rests with the parent or guardian. If the parent or guardian decides that an escort will not be necessary, the letters "NR" (Not Required) should be entered in the sections relating to escort. However, if the parent or guardian exercises this option, the unaccompanied child will, on all occasions, be treated by the airline as an adult passenger.
